What Is It?

Cardiokinase™ w/CoQ₁₀ offers enhanced support for healthy cardiovascular and cerebrovascular circulation with an advanced nattokinase and CoQ₁₀ complex.*

Uses For Cardiokinase™ w/CoQ₁₀

Healthy Circulation: Cardiokinase™, like other nattokinases, is produced via fermentation of the Japanese food natto with *Bacillus Subtilis*. Similarly to nattokinase, Cardiokinase™ offers support for healthy fibrinolytic activity and clotting function. However, Cardiokinase™ is characterized by several distinctions:

- It is produced using a newly isolated strain of *Bacillus Subtilis*, strain "N", that has indicated the potential for higher activity compared to other strains
- It utilizes international units to measure nattokinase enzymatic activity
- It has the ability to support kinin production for healthy vascular dilation and a healthy inflammatory response*
- It may have over 10% greater lymphatic absorption and 20% greater effectiveness compared to other nattokinases*
- It has demonstrated quantitative support for healthy blood viscosity*

What Is The Source?

Cardiokinase™ is derived from fermentation of *Bacillus subtilis* "N" and boiled soybeans. CoQ₁₀ is derived from fermentation. Ubiquinol (Kaneka QH™ active antioxidant form of coenzyme Q₁₀)[†] is produced by microbial (yeast) fermentation. There is no residual yeast in the final product. Ascorbyl palmitate is derived from corn dextrose fermentation and palm oil. Gelatin beadlet is porcine. Mixed tocopherols are derived from highly purified soybean oil.

Cardiokinase™ (nattokinase strain N) (25 i.u.) (from non-GMO soy) 100 mg
coenzyme Q₁₀ 60 mg
ubiquinol (Kaneka QH™ active antioxidant form of coenzyme Q₁₀) .. 40 mg
ascorbyl palmitate (fat-soluble vitamin C) 10 mg
other ingredients: gelatin beadlet, cornstarch, mixed tocopherols

Take 1 capsule in the morning and 1 capsule in the evening, 1/2 hour before meals.
